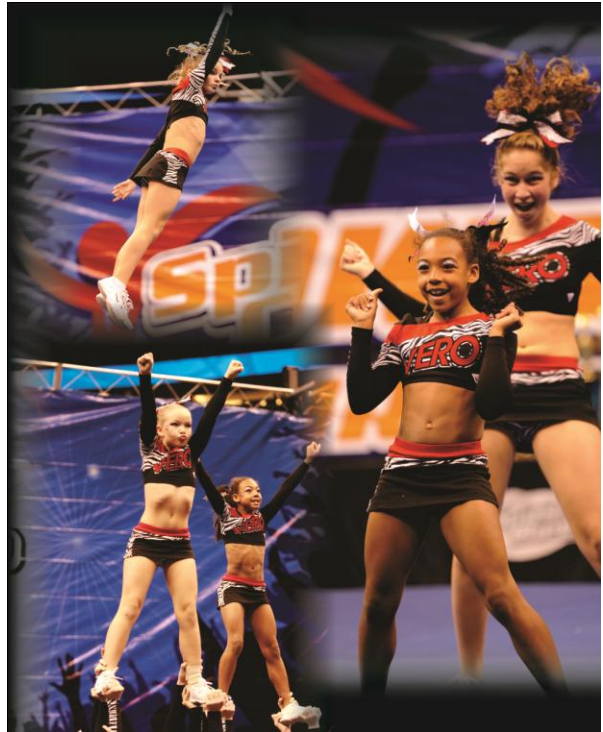




PARENT ATHLETE INFORMATION Packet

ALL-STAR CHEERLEADING can be one of the most rewarding experiences for a parent and child. However, drama in a cheer gym can ruin even the most successful programs, and thus will not be tolerated. Our promise to you is - We will make our gym the most enjoyable place possible for the majority of our clients and will give you the most value for your family's dollar.

PROBLEMS WILL BE REMOVED! Please approach Kelly or Chad immediately if you have a legitimate complaint about a parent, child or coach that is causing you to have a negative experience at Vero Cheer. Please consider the age of the child and a parent's desire to be part of the experience, before bringing an issue to light. Keep in mind that we will go directly to the problem and solve it at that moment. A certain amount of disagreement should be expected on any team, but it is the job of every adult in our gym to control themselves and their children.

ABSENCES

We expect 100% dedication to your team. That means attendance is **MANDATORY**. Schedule all of your outside commitments, appointments on days off from the gym.

Excused Absences include:

A school function approved 2 weeks in advance, and not within 2 weeks of competition.

A death in family

A contagious illness, as decided by the coach or doctor. (Requires doctor's note)

Unexcused Absences include, but are not exclusive to:

Jobs, Birthday parties, concerts, banquets, family reunions, weddings, dances

School projects, homework, tests, dentist and doctor appointments.

It is extremely important that athletes be on time and do not miss practice.

Excessive tardiness could result in dismissal from the program. If you do not show up for a competition you will automatically be removed from the next competition. You must attend practice if you are injured or sick but not contagious. Too many unexcused absences could result in dismissal from the program. Anyone that quits or is dismissed from the program will not receive a refund of any fees that have been paid. In most cases, anyone that quits the program will not be allowed to tryout the following season. Athletes that quit and wish to return the following season will be reviewed on a case by case basis.

During the summer months, up until your choreography dates, you will be allowed to miss practice as needed for family vacations, camps, etc. After choreography, the attendance policy will go into effect. We cannot stress enough how important it is to be at every practice. Stunting, tumbling, and choreography are taught at every practice. When you miss, you hold the entire team back.

TARDINESS

You are considered tardy if you are not on the practice floor and ready when your practice **BEGINS**. Athletes should be fully dressed and ready at this time. Do not enter the practice area early.

CHOREOGRAPHY

At Vero Cheer, we are very proud of our ability to choose the best music, dances, motions, stunts, and jumps, and to make changes as we see fit. We will be competitive. We study the best teams in the country and are constantly learning new ways to improve our routines. We appreciate any cool new ideas that you create or find. Please understand that we know the rules, and there are some things we can't do. Music must be appropriate and well paced.

INJURIES

If an injury occurs, the child must seek medical attention for the injury and could result in temporary inactivity from the team. **YOU MUST STILL ATTEND ALL PRACTICES AND PAY ALL DUES.** A written doctor's note must be turned in along with the approximate date of return. Upon return to the team, there must be a doctor's note on file releasing the athlete to do all physical activities.

TRAVEL

- All cheerleaders will use the same accommodations at all out of town events unless approved in advance. We do not want to approve separating your child from the team. Do not book non-refundable fares, it will only cause problems.
- There must be a parent in every room, **no exceptions.**
- Every cheerleader **must have a chaperone at every competition.** It is not your coaches', team moms', or any Vero Cheer staff members' responsibility to be your child's chaperone.
- Hotel costs are your responsibility, Vero Cheer will reserve a block of rooms at the hotel of our choice. Safety is a factor when selecting hotels. Be prepared to pay \$99 - \$150 per night for a hotel room.

DRESS CODE

- During team practice, red, black, white, grey team t-shirts & shorts must be worn. Extra shirts & shorts must be purchased if you forget. We must look like a team when we practice as a team.
- Sports bras should always be worn under t-shirts.
- No bra straps showing. Parents – please help enforce this rule.
- If your child is a flyer or is taking a stretch or stunt class, they should ALWAYS wear bloomers or tight fitting shorts under their cheer shorts.
- **NO JEWELRY!** (At practice & competitions)
- Fingernails must be kept short. (no polish at competitions)
- Hair must be up and out of face.
- **SHOES MUST BE WORN TO EVERY PRACTICE.** Forget your shoes and you will be asked to keep an extra pair at the gym. **NO SHOES/ NO PRACTICE.**

COMPETITION DRESS CODE

- At no time should your skirt be worn over your pants.
- No jewelry or nail polish on competition day.
- When not in uniform, wear your Vero Cheer t-shirts and warm up pants or shorts.

UNIFORMS & SHOES

It is your responsibility to rent or purchase your full uniform. You are required to purchase practice clothes, shoes, hair bow, and make up. Payment is expected at time of order. One pair shoes that are specifically designed for spring floors must be approved and purchased for competition.

You will be responsible for the care of your uniform and will be required to pay for replacing it at the discretion of the owners of Vero Cheer. Please take care of your shoes and only wear them to practices, competitions and on spring floors. If your shoes are inadequate for competition, you will be asked to purchase a new pair.

All uniforms must be returned within 10 days of the final competition or immediately if leaving or removed from the program. If you do not return the uniform you will be liable for the cost to replace it (\$200), plus shipping and handling. You also agree to pay any additional monies for collection services, and any attorney/ court fees applicable to attain damages.

FINANCIALS

Gym Fees/Tuition - \$75 per month Junior/Senior, \$60 Mini/Youth, \$45 Tiny, \$45 Dance.

Crossover Tuition for Dance - \$25 per month (Sept/Apr)

Competition Uniform - \$200-\$225 to purchase or rent for \$75 per year.

Dance uniform - \$75-100

Practice Clothing - \$25 (includes 3 tees)

Shoes - \$30-\$75 (see coach for approval)

Hair bows/Makeup– \$25-\$30

Summer Camp - \$100 Junior/Senior, \$50 Mini/Youth/Dance

Choreography & Music* included.

Coaching Fees *included

Competition Fees - \$600 Senior/Junior/Youth/Mini, \$300 Tiny/Dance

Prices noted here are for informational purposes only and are subject to change without notice. You will receive a statement via email with account balance due.

You will be required to have a credit card on file. If payment is not received by the 10th of the month, the credit card will be charged. If the credit card is not processed, there will be a \$20 late fee added to your account and your child will sit out during practice until account is paid. No exceptions. AUTOPAY is available. If you do not have a credit/debit card, you will be required to pay one month's tuition in advance.

SUMMER CAMP – WEEK OF JULY 11th

- Junior & Senior teams will travel to Orlando for a 2 day camp. Cost is \$100 and includes 1 night hotel. Transportation & Chaperones needed.
- Dance, Mini & Youth teams will travel to Orlando for 1 day camp. Travel and hotel are not included. Cost \$50. Transportation needed.
- Tiny team will have half day camp in Vero.

COMPETITIONS

- All teams will travel. Travel to & from is your responsibility. Carpooling is suggested. Area – within 2.5 hours distance, Daytona to Tampa to South Florida.
- Competition season begins in December and will end in April.

PARENT/CHEERLEADER CODE OF CONDUCT

- If you experience a situation that requires assistance, help please do not hesitate to contact your coach then the owners. We pride ourselves in making this experience a positive and rewarding one for you and you athlete(s).
- Only coaches and athletes are allowed on the practice floors and equipment. As a parent you are also responsible for supervising your children that are not Vero Cheer students.
- Clean up after all members of your family and any guests you bring to the gym. If you bring it in, take it with you or throw it away. If you move a table or chair put it back. Leave it how you found it!
- All-Stars are expected to be at **every** squad practice. If for any reason you cannot attend a practice, you are expected to contact the gym **and** coach, via phone, text or email, to notify them of the absence **prior** to the scheduled practice time. Failure to comply will result in sitting out the first 30 minutes of an additional practice and using the time for conditioning.
- It is your responsibility to wear the appropriate practice wear to **every** practice. T-shirt with sleeves, cheer shorts and cheer shoes. Our colors are Red, White, Black, Silver (Grey). Any other color clothing is not allowed. Spankies are suggested for all athletes. Hair must be pulled back away from face. (ponytail, braid etc.)
- Any additional clothing (sweats, long pants, etc), cell phones, school bags or gym bags must be stored away from the practices area. Cell phones need to be turned OFF when practice starts.
- Please respect each other as teammates and address any issues between athletes with your Coach immediately.
- Parents are not to get involved with issues between athletes. Parents are not to talk about any other athlete's abilities or positions. Parents are not to cause issues or drama in or outside the gym. Parents are not to talk about quitting the gym if they don't get what they want. Parents are not to talk to other parents about going to other programs. Parents are not to scream out during practice. Parents are not to point out to a coach what they see from the viewing area about another child. ALL PARENTAL CONCERNS SHOULD ONLY BE ADDRESSED TO THE COACH OR OWNERS. This section is probably the most important to follow for overall gym success! Failure to comply will result in removal from the Vero Cheer Program.**
- Parents please understand that you can ruin another family's experience at our gym. We want everyone to feel comfortable and welcome to watch practices without having to listen to drama. If you are not a positive person, please choose to drop your child off at the gym and pick them up after practice.**
- Facebook** is to be used for praise only. Please get permission from the parent before posting about another child. Please do not send information to other parents, in order to ensure accuracy, leave that to the gym. Remember that you are representing the gym at all times.

_____ Initial (page 1 of 2)

- No profanity or abusive language at any time in the gym. Do not intimidate teammates.
- You must arrive at all practices, competitions, or any scheduled event on time. Punctuality is a MUST. **All** absences and tardies will be posted in a public place for all to see. Don't be that person!!! Parents, it is your responsibility to schedule all appointments, vacation, etc. on gym days off. Parents, it is your responsibility to manage your child's homework and school load. **Procrastination is not an approved reason to miss practice!** Please consider if your child misses a mandatory practice or event you are wasting another parent's hard earned money and hurting the team's chances for success!
- Squad and routine decisions are left to the discretion of the coaches. All decisions about what team an athlete is on and what place/ position the athlete has on that team will be decided by the coach and owners. **Parents and Athletes should prepare for constant changes! There are no set positions/ groups/ teams/ etc. Do your best and we will make the decision. Remember that you are paying for a coach!**
- Feel free to talk with your coach about anything squad related, just remember to do it at an appropriate time and in the proper manner. The best times would be before 4pm.
- The dismissal/addition of an athlete is solely the coach's decision.
- Practices may be changed or added at any time during the season.
- It is the parent's responsibility to know what is going on with your squad. Check your emails, the website, and with your team coach regularly.
- We require that you attend the performances of every squad on Competition day at every event unless stated otherwise. Athletes are also required to attend their own awards session. Parents please worry about where your child is and let us worry about others.
- All parents and athletes are required to yell the chant during all squad's performances. "Let it be known...the champions are here...red, silver, black...Vero Cheer! We want those spirit awards!
- Parents and athletes should show good sportsmanship at all times.
- Gym management reserves the right to change gym policies at any time.
- Anyone threatening to quit or pull their child from a squad will be dismissed from the Vero Cheer program immediately.

Wash & Care Instructions for Motion FLEX Uniforms – Mini/Youth/Junior/Senior

Specialty fabrics are more delicate due to their unique fabric content and may experience color transfer if proper care instructions are not followed. These fabrics may have potential to fade or rub off with normal wear and tear, especially in high contact areas.

1. Wash garments separately from other clothing.
2. Do Not Bleach or use Fabric Softeners.
3. Wash in Cold Water Only.
4. Hand Wash or Use Permanent Press Cycle at Full Water Level.
5. Remove Promptly & Drip or Line Dry. DO NOT use Dryer.
6. DO NOT Dry Clean. (this will cause the fabric to yellow)
7. DO NOT Iron.

****** Underwear MUST be worn under the boy shorts that are attached to the skirt.******

RULES

1. Do NOT alter uniform without permission from Coach Kelly
2. Do NOT remove tags.
3. When in uniform, I am expected to represent the gym in a positive manner. Bad sportsmanship, foul language or inappropriate conduct may result in dismissal from the squad with no refund.
4. Uniform must be returned by April 24, 2012 or you can purchase for \$125 to use next year.
5. Uniform must be returned immediately if you resign from or are removed from the program.

Wash & Care Instructions for Poly Uniforms – Tiny

Specialty fabrics (Silver) are more delicate due to their unique fabric content and may experience color transfer if proper care instructions are not followed. These fabrics may have potential to fade or rub off with normal wear and tear, especially in high contact areas.

1. Wash garments separately from other clothing.
2. Do Not Bleach or use Fabric Softeners.
3. Wash in Cold Water Only.
4. Hand Wash or Use Permanent Press Cycle at Full Water Level.
5. Remove Promptly & Drip or Line Dry. DO NOT use Dryer.
6. DO NOT use Dryer. (this will cause Silver to fade)
7. DO NOT Dry Clean.
8. DO NOT Iron.

****** Underwear MUST be worn under the bloomers that are attached to the skirt.******

2. Do NOT remove tags.

5. Uniform must be returned immediately if you resign from or are removed from the program.
